- Membership of the majority of former communist countries;



## Obstacles of Political Pluralism of the Western Balkans

- Difficulties in establishing and consolidating the rule of law;
- The absence of separation of power and the inability to establish legal and constitutional functional system;



## Internal and Regional Insecurity of Western Balkan Countries

- The absence of the political will for cohabitation as an obstacle for establishment of common interest;
- Increase of international criminality as an obstacle for the enforcement of the regional security;



### Differentiated Progress of the Former Communist Countries towards EU enlargement

- The complex of certain countries in the Balkans to fulfill membership obligations;
- The ethnic conflicts as an obstacle towards EU integration and potential threat to the internal security of European Union;

 European Union proposal to engage gradually towards integration Western Balkan countries;

### **Humanitarian Crisis of Emigration**

 Increase of insecurity of EU in absence of consensus over the Dublin Regulation;

 Police collaboration of the Balkan countries for the security of external borders of EU;



## Increase of Attention of Member Countries in towards Western Balkans
